Please see trailing email regarding "Pendency in GSTIN cancellation". We are facing following reasons regarding pendency of cancellation applications in UP

1. There are huge number of applications related to cancellation which are not available in any jurisdictional office or available in deactivated jurisdiction offices which is primary reason of pendency in UP.

2. Also there is secondary reason of tax official's jurisdiction change from one office to another office.

Following actions are taken by state for removing the pendency

1. State is in continuous contact with GSTN to remove technical hurdles in BOWEB portal regarding jurisdiction related issue.

2. Also Tax officials are given instruction to remove pendency asap from activated & deactivated jurisdiction offices.



The undersigned is directed to inform that PMO has noted adversely regarding delay in processing cancellation of GSTINs and had observed that this is forcing people to file nil returns and it is also leading to corruption.

2. It is requested to expeditiously take necessary action to reduce the pendency in respective States/UTs. State/UT wise pendency of GSTIN registration cancellation requests with the State/UT tax authorities as on 27.08.2018 is enclosed for reference (**Annexure 1**).
3. In view of the above, it is requested furnish comments/reasons regarding the pendency of GSTIN cancellations and action taken thereon to reduce the pendency by 31.08.2018.
4. This issues with the approval of the Joint Secretary, GST Council.
