**VYAS-** An integrated e-Governance solution of Department of Commercial Taxes, Uttar

Pradesh to provide effective and efficient system of collection of taxes based on progressive use of Information technology and to ensure an environment which is congenial for prospering of Trade & Commerce in the state of UP covering 1349 sector offices in 95 locations in 75 districts.



VYAS has got two major categorization of inter-related web applications based on various automated services of the department:

1. Intranet web applications on various automated services – Single sign-on for officials
2. Online services for around 1.3 million registered Dealers – TIN based login.

Digital transformations in Dealer services under the project:

- E-Assessment (Notices & orders) is one of its kind automation for the Department, Uttar Pradesh is the first State in the Country to generate online orders & notices in format which not only includes relevant mandatory fields but also flexibility to generate even bigger orders through Offline tool. Technologically, Microsoft Word Template as offline tool to write the 40-50 pages long notices/Orders and on uploading the same, combining it as running text in HTML during Notices/Orders generation on the fly in ASP.NET Programming, was new that has been incorporated in the system. This solution was widely accepted and E-assessment could be a success in real time.
- Unique Detention memo No. generation via PULL SMS has been appreciated as best innovations in monitoring of seized vehicles in order to stop/ reduce tax evasion.
- Online Reconciliation of Tax deposit from Treasuries and Banks.
- Online availability of Acts/Rules/Notification/Orders/Tax Rate/Commodity Codes etc.
- Online Tax Collections and return file monitoring.
- Department statistical reports and formats related to department available on the system through MIS.
- All employee records available on the system.
- All Dealer database is available on the system
- Risk profiling & Assessment has been made faster, transparent and its monitoring is easy, a few clicks away.
- E-Registration has eased both ends i.e. dealers & Officials and is saving time, more transparent & widely appreciated.
